With effect from 1 April 2008, any applicant who has used deception in a previous entry clearance application will have future entry clearance applications refused for ten years.

**Translation of documents 文件翻譯**

Any documents that have to be submitted in support of points claimed, which that are not in English or Welsh, must be accompanied by a full translation that can be independently verified by the UK Border Agency. The original translation must contain:
